### **COVID-19 LIABILITY RELEASE:**

I hereby release and agree to hold Fishing for Life harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the salon, or that may otherwise arise in any way in connection with any services received from Fishing for Life.
